Call to the Republican Electors of Colorado County.

By virtue of authority vested in me as chairman of the republican executive committee as directed at a meeting of said committee it is hereby directed that a county republican convention of delegated representatives of the republican party of Colorado county be held in the city of Columbus on Tuesday, May 5th, at 2 p. m. for the purpose of electing delegates to the state republican convention at Fort Worth on the 15th day of May, 1908, and for the further purpose of electing delegates to the congressional republican convention of the ninth congressional district of Texas. The basis of representation to be used in such county conventions is one vote for the precinct and one vote for each 25 votes cast for C. A. Gray for governor in the precincts in the elections of 1906; the precincts being as follows: Columbus, 2 votes; Altair, 1 vote; Garwood, 1 vote; Rock Island, 1 vote; Oakland, 1 vote; Weimar, 4 votes; Borden, 1 vote; Brushie, 1 vote; Shaw's Bend, 1 vote; Santa Anna, 0; Freshburg, 1 vote; Bernardo, 1 vote; Eagle Lake, 5 votes. The credentials of each precinct must be in the hands of the Secretary not later than 9 a. m. on the 5th of May, in order to prepare a temporary roll.

Splendid porcelains, said to be the best of its kind, have been manufactured from the kaolin taken from the mines in Edwards county.
