What's the Matter With Colorado County's Road System?

A great many taxpayers have the idea that a considerable portion of our County Road and Bridge Funds are used inefficiently, and that perhaps the Commissioners Court is to blame.

In order to investigate and determine what was the trouble, Messrs. M. E. Guynn, W. E. Welford, John Matthews, M. G. Calvert, C. H. Brosig, and other Eagle Lake citizens, spent several hours with the Commissioners Court going over the matter, and the net result of their visit was

FIRST: The total annual amount paid into the Road and Bridge Fund (after allowing for the expense of collection and delinquents,) is about \$26,000.00.

The expense of repainting and maintaining the 10 steel bridges and maintaining the Poor Farm, per annum, is \$18,000.00 leaving a balance of only \$8,000.00 which is apportioned among the four Commissioners' Precincts, giving each one about \$2,000.00 per year, which must serve to maintain all old culverts and bridges, costing less than \$500.00 each, build all new culverts, open and grade all new roads, and maintain all old ones.

SECOND: In view of the fact that there are more than 600 miles of road in the county, it is plain that the amount of money is evidently too little to accomplish any permanent good.

THIRD: After a thorough sifting of the matter, and acting on the advice of Judge Mansfield, it was decided that the best way (and in fact the only way) to raise the necessary funds, was to issue bonds.

FOURTH: It is estimated that there is something more than 80 miles of Public Road in Eagle Lake Justice Precinct, and the plan proposed is to issue bonds for \$100,000, which would be sufficient to grade up and thoroughly drain every road, expending on each one an amount proportionate to its importance and utility.

The idea is to elect a Committee of citizens residing in the District—one from each community, who would have charge of the planning and execution of the work.

The election will be ordered for Tuesday, Sept. 17, and it is practically certain there will be no opposition.

Eagle Lake's first bale of cotton of the 1912 season was received here Tuesday, and was raised by Mr. F. W. Wagner. The bale weighed 560 pounds and was sold to E. L. Mooney for 18.00. Eagle Lake is progressive in all other lines, but it seems that we are a little behind on offering premiums on the first bale. No premiums were offered.

Sunday was the hottest day of the year, the thermometer registering 104, and 102 on Monday. Crops, especially young cotton, are burning badly and rain would not only be a help to the cotton but also a relief to the people.

Mr. Geo. Brower and family, who have been conducting the former Hanly restaurant, have given up same and returned to Garwood. The building has been rented by Mr. L. Shepard, who has same closed this week making repairs and remodeling. He hopes to complete the repairs and be open for business tomorrow or Monday.

During the past three weeks, according to interviews with prominent farmers of this section, the condition of the cotton crop of this section has materially changed for the worse, and at the present date the situation is becoming alarming on account of dry weather and excessive heat. Up to July 1st the plant in this section was doing well, making good growth and fruiting nicely, and this condition was sustained mainly by the moisture conserved during the winter and early spring months, as the rainfall in June was not sufficient to be of much benefit. Since the beginning of the month the weather has been very hot, ranging from 93 to 97 degrees, and exhausting every bit of the moisture. This has caused cotton to stop growing, and to shed rapidly, not only the blooms but many small bolls.
