School Election Saturday

An election will be held in this city on Saturday, July 10th, to determine whether or not the city of Eagle Lake and some adjacent territory shall incorporate under the name of the Eagle Lake Independent School District. The territory proposed to be incorporated includes some lands in addition to that now included in the present Eagle Lake school district.

The advantages to be gained by incorporating as an independent district are to relieve the city of the bonds, the assessing, the levying of the school tax, and in fact, placing all school affairs in the hands of the school board. This is the desire of the city council and also of the board. The limit of taxation under the new district will be fifty cents, including both bond and maintenance taxes, while under our present district the limit is only ten cents.
