WEIMAR GETS SOME HARD SOAKING RAINS

Weimar, Tex., Sept. 8.—Since yesterday afternoon this section has literally been flooded with rain. A heavy rain lasting for several hours fell Sunday afternoon, and beginning at 4 o'clock this morning one of the heaviest downpours of the present year has been falling. Up to noon today it fell without cessation, and the outlook is for still more. The damage to the cotton in the fields is incalculable. Due to lack of pickers and numerous rains of the past week, a great deal of cotton open in the fields has practically been ruined. Many farmers will lose from six to eight bales to the field, as the cotton has been blown or washed on the ground and will sprout before the cotton can be picked. The rivers and creeks are booming, many of them out of their banks, and fields are badly washed.

Another fine rain fell here this morning, soaking into this old parched earth and cooling the atmosphere. The rains are too late to be of any benefit to any kind of crops, doing damage at this time, the harvesting time, to both rice and cotton.
