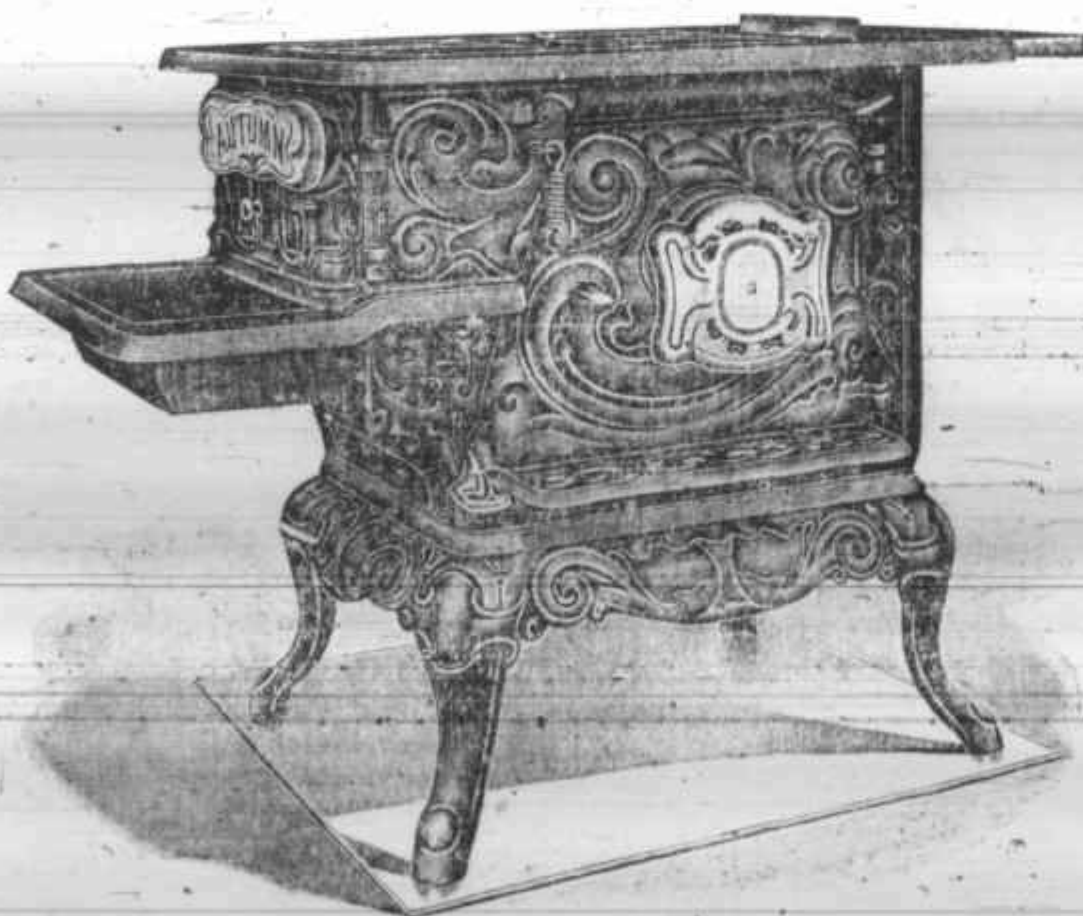

"Charley Woodward is dead." Those words went from person to person on Wednesday morning when the news of his death was telephoned here from San Antonio. On Wednesday, just a week before his death, Mr. Woodward was taken ill and on the following Friday was taken to San Antonio for an operation for appendicitis. He was operated on soon after his arrival there but his condition was such that he would not survive the operation. Charley Woodward was one of the best men in Eagle Lake, and in his death, our town has lost a faithful friend and our community one of its most useful citizens. His life's work was caring for others—visiting the sick, the poor and the needy, administering to their wants and nursing and waiting on them during their illness, and comforting them during their afflictions. His place in this community is going to be hard to fill—for there never has been another just such a man as Charley Woodward, and there may never be. He is going to be missed by the people of this section. People of all classes will miss him, but especially will he be missed by the poorer people in their hours of affliction, for it mattered not to him whether the person suffering or in trouble was rich or poor, Charley

Woodward was always there. Just a few short weeks ago the people of Eagle Lake, through a subscription list to this paper, presented Mr. Woodward with a buggy and horse in appreciation of the good work he was doing for the town and community, that he would be in a position to better carry on this noble Christian work. Little did the people who gave to that fund realize that in a few more weeks, big, strong, would be among the dead. But we are glad we gave it to him. It was a bouquet while he lived. He knew by it that his work was appreciated, and that one token was more to Charley Woodward than all the things that we can now say in the paper of him or all the flowers that were spread upon his grave. Almost those words he told us—"It's a bouquet while I am yet alive to enjoy its fragrance!" Charley Woodward was a life long member of the Baptist Church, and a faithful member. Just a few days ago he was on our streets, strong well and healthy. Today he is dead! It is hard to realize, yet only another instance of no one knows when the summons will come. The funeral was held Thursday afternoon in San Antonio. To his aged mother, the Headlight extends its heartfelt sympathy.
