EARLY POTATO DIGGING WILL BEGIN NEXT WEEK

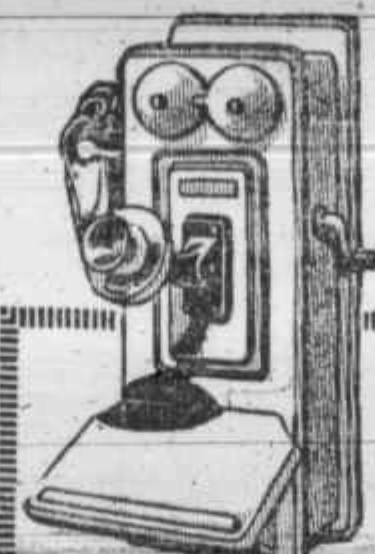

COMMISSIONERS COURT

DISCUSSES DRAINAGE

At Call Session of the Court, Colorado County Drainage District No. 1 is Discussed.

In the matter of Colorado County Drainage District No. 1, the report of John A. Norris, Civil Engineer, heretofore appointed by this Court to locate the necessary canals, drains and ditches, laterals and levees, and make an estimate of the probable cost of making and completing each of them etc.; and it appearing to the court that said report has been made and filed in this court in compliance with law and the order of this court, estimating the cost of improvements of said proposed drainage district at the sum of \$17,000.00 and it appearing to the court that said legal notice thereof has been given as required by law, the same was approved and ordered to be recorded by the clerk of this court.

In the matter of Colorado County Drainage District No. 1, the report of the Civil Engineer has been heard and approved and ordered recorded in the minutes of this court.

It was ordered that an election be held within the territory of such proposed drainage district on the 4th day of June, A. D. 1914, for the purpose of establishing a drainage district, to be described and designated as Colorado County Drainage District No. 1, and for the issuance of bonds and the levy of a tax in payment therefor, at which said election there shall be submitted the following propositions, and none other: "For the Drainage District and the issuance of bonds and levy of a tax in payment therefor." "Against the Drainage District and the issuance of bonds and levy of a tax in payment therefor," the amount of bonds being for the sum of \$17,000.00, to pay the estimated cost of improvements of said proposed drainage district.

Said election shall be held at the following named places within the territory of said proposed drainage district, and the following named persons have been appointed as managers and officers at said election: At New Hope School-house: A. B. Winzenried, presiding judge; W. O. Trafton, assistant judge; M. P. Meek, clerk; W. H. Winzenried, clerk. At Sterling Fling's residence: F. C. Koons, presiding judge; Wm. Largent, assistant judge; John Kallins, clerk; Sterling Fling, clerk.

None but resident property taxpayers who are qualified voters of said proposed Colorado County Drainage District No. 1 shall be entitled to vote at said election.

The court took under consideration the bids for the county printing and advertising in compliance with the order of this court of the 6th day of April, 1914; and it appearing to the court after examining all bids presented that the bid of the Colorado Citizen is the lowest and best bid, the same was accepted.
