## FUNERAL FOR MRS. W. HEINEY HELD ON LAST SATURDAY

Services Held At Home For Highly Respected Citizen Of City, With Interment In Cemetery At Lakeside.

Funeral services were held Saturday afternoon at 2 o'clock for William Heiney, who passed away shortly after noon on the previous day. The services were conducted by Rev. N. G. Oment, local Methodist pastor.

Mrs. Heiney was one of Eagle Lake's finest women, and was held in high esteem by everyone who knew her. She had returned only a week previous from a three months' visit to her daughter in Memphis, Tenn., having for some time suffered from asthma, and had made the extended stay hoping to be relieved from her sufferings. She contracted influenza on her return, and was not feeling good at the time she came home. Her illness developed into pneumonia during Thursday night, and she passed away shortly after noon Friday.

Mrs. Heiney was 68 years of age, having been born in Upper Sandusky, Ohio. She was married at that place on January 25, 1887, to Mr. William Heiney, who, with her two daughters, Mrs. A. Towns of Eagle Lake and Mrs. R. Lee Elliott of Memphis, Texas, survive. Shortly after their marriage, Mr. and Mrs. Heiney moved from Upper Sandusky, to Cincinnati, Ohio, where they made their home until 1906, when they moved to Eagle Lake, living on a farm four miles from Eagle Lake. The family moved to another farm near Eagle Lake where they made their home for about three years, moving to Eagle Lake and purchasing the Brown Hotel building in 1913, and have since conducted that hotel, and made that their home.

Shortly after noon Friday, Mrs. Heiney closed her eyes to the scenes of earth and entered into eternal rest. The summons from the shadow came to this good woman after an illness of less than a week, during which she made a brave fight for life, but the disease mocked at medical science, nursing and prayers, and shortly after noon Friday the angels came to take her spirit home and leave her in a lifeless clay.

She was a woman of judgment and great energy, kind of heart and sympathetic, and was useful to the community and cheerful to her friends, who deeply sympathized with the sorrowing relatives.

## COUNTY OFFICERS WILL BE SWORN IN MONDAY

The following is reprinted from last week's issue of the Colorado County Citizen:

The official family of Colorado county will be shaken up quite materially by new officers assuming their duties next Monday.

Henry P. Hahn will take oath of office for County Judge, R. R. Hadden for Commissioner of Precinct No. 1, Phillip Kanstner for Commissioner of Precinct No. 2, H. B. Reading for Commissioner of Precinct No. 4, and E. R. Spencer for County Attorney.

In Justice Precinct No. 1, H. L. B. Skinner will take the oath of Justice of the Peace and J. R. McMahon will take the Constable office.

Other county officers and holdovers, re-elected in November, as follows: W. C. Papenberg, district clerk; John Hasted, county clerk; Frank F. Hoemeyer, sheriff; Emil H. Rabel, tax collector; Henry Buescher, tax assessor; Jno. F. Kinetka, treasurer.

One of the old office holders in the county, County Judge E. B. Mayes, yields the reins to the present Justice of the Peace, Henry P. Hahn. Judge Mayes served the county in the capacity of sheriff for eight years, elected to that office in 1908 and holding it until 1916, when he was elected County Judge, which office he held continuously, with the exception of one term, up to the present time.

Judge Mayes has been an able, zealous, impartial and efficient officer of the county during those twenty-two years, working with earnest care for the interests of the citizens and tax-payers. No man who has held the office of County Judge so long could be free from some criticism, and Judge Mayes has drawn his share of censure. Nevertheless he has rendered to this county a service that merits recognition from thinking people, and the Citizen welcomes the opportunity of recording a testimonial to his faithful performance of duty.

There are other noteworthy efficient and experienced individuals in our cabinet of county officials. County Clerk John Hasted has been the county's genial and affable clerk since the day Judge Mayes was elected to the sheriff's office, and is as willing and eager to accommodate the patrons of his office today as he was when first inducted into office. District Clerk W. C. Papenberg is another old official who has stood the test of twenty-four years of service in his office. All who have business with either of these two county officers will attest to their efficiency and ability.

With a complete set of good and dependable county officials in our county court house, these three men have been given this special mention on account of their long service to the county, and especially Judge Mayes, who has voluntarily retired from the official family.

## TWO WELLS SCHEDULED FOR EARLY DRILLING IN THE GARWOOD SECTION

Coyle-Concord-Humble Make Location Near Gasser, and Drilling Company Is Erecting Rig Three Miles From Garwood.

Oil activities are being revived in the Garwood section with the New Year.

The Humble Company, according to reports, has become associated with the Coyle-Concord Oil Company, and a new well is to be drilled by the Coyle-Concord-Humble people.

According to one report the new location will be on the same block of the present Coyle-Concord gas well about 2000 feet south, and another report reaching the Headlight is that the new well will be drilled on an adjoining section about one mile north of the present well.

According to reports, the Humble Company has purchased a block of the Coyle-Concord leases and will have men and material on the ground for spudding in the new well within a very few days. It is said that the same rig used in the first Coyle-Concord well will be used in drilling the second well and that the same crew employed on the Coyle-Concord well will be on duty.

Temporary offices of the company have been established in Columbus. There is some activity in leases and inquiries as to price of royalties in the Garwood section.

The Dandiger Company is erecting a rig on the C. L. Raver land, three miles west of Garwood, on leases owned by F. F. Hodges and L. E. Hults of Fort Worth. This well is nearly on a line with the W. M. Griffiths land.

Died At Corpus Christi, Where He Was With Central Power And Light Co., Few Hours After Suffering Stroke.

Funeral services were held here Monday at 2 p. m. for Ernest P. Newsom, 54 years of age, who was born and reared in Eagle Lake, and who lived here until manhood. He moved away from Eagle Lake about twenty years or more ago, and has been back to the town of his birth but few times since.

He was a son of Mr. and Mrs. E. P. Newsom, well known and old-time citizen of Eagle Lake, both of whom sleep their last long sleep in the Masonic cemetery here, his mother having passed away in 1928.

Mr. Newsom died of apoplexy at his home in Corpus Christi, where he was connected with the Central Power and Light Company, having lived only a few hours after having been stricken on Saturday afternoon. While he had not been in good health for some time, the end came suddenly and unexpectedly.

The remains were shipped to Eagle Lake on the 11 o'clock Southern Pacific Monday, interment being held in the Masonic Cemetery at 2 o'clock in the afternoon. A short service was conducted by Rev. N. G. Oment, local Methodist pastor, following which Masonic ceremonies were conducted by the local chapter of Masons, he having been a member of the Masonic fraternity.

Ernest Newsom was a fine man, having been the first of a family of eight children to receive the call from the shadows. He was popular with the people of Eagle Lake and was held in high esteem by all who knew him here. The older citizens of Eagle Lake, who remember him so well, who were associated with him in childhood's happy days and throughout the care-free days of young manhood, grieve deeply over his passing.

He is survived by his wife and one daughter, Anna Laura, three sisters, Mrs. L. Minnis of Houston, Mrs. A. G. Reynolds of Lockhart, Mrs. Mary Smith of Freeport and W. D. Newsom of Lockhart, Jim Newsom of San Antonio, Tom Newsom and John Newsom of Corpus Christi, who have the sincere sympathy of all who knew him.

The old Newsom homestead is the home now occupied by Miss Mary Potter, and was a general meeting place and playground for the children of Eagle Lake of the long ago.

Mr. Bodle is survived by his wife and two sons, one seven years of age and the other a baby boy of five months; his parents, Mr. and Mrs. L. E. Bodle, and one brother George, whose home is in Chicago but who has been with his family here for several months, and who was at his brother's bedside when the end came.
