NOTICE AFFORDING OPPORTUNITY FOR PUBLIC HEARING
CORRIDOR (LOCATION) AND DESIGN (COMBINE HEARING)

The Texas Highway Department is proposing the construction of FM Highway 3013, from the junction of US Highway 90A and FM Highway 3013 (formerly FM Highway 108) at Eagle Lake to FM Highway 102 in Wharton County.

The proposed construction road (known as the Eagle Lake-Glen Flora Road) will have some modifications at curve locations, and will consist of two 13-foot surfaced traffic lanes and two 9-foot shoulder shoulders on a minimum right-of-way width of 120 feet. The present right-of-way width on the existing road is 60 feet minimum and 100 feet maximum.

Maps and other drawings showing the proposed location, geometric design, environmental features and any other information about the proposed project are on file and available for inspection and copying at the Resident Engineer's Office on US Highway 90, 5 miles West of Columbus, P. O. Box 117, Columbus, Texas. The drawings show the proposed design, the drawings showing the proposed geometric design have been placed on file in the offices of the Wharton County Judge, Colorado County Judge and the Mayor of Eagle Lake.

The layout men, painters and the relocation assistance office as well as information about the tentative schedules for acquisition of right of way and construction can be obtained at the Resident Engineer's Office.
