NOTICE OF PROPOSED ABANDONMENT

Notice is hereby given that the Interstate Commerce Commission is being requested to West Issue - certificate of public convenience and necessity permitting abandonment of the line of railroad of SOUTHERN PACIFIC TRANSPORTATION COMPANY extending from railroad milepost 0.00 near Altair in a northerly direction to the end of the line at railroad milepost 9.02 near Helms, a distance of 9.02 miles, in Colorado County, Texas. This line includes the station of Helms.

The interest of employees will be protected by imposition of the "Baraburton Condition" (Chicago, BQ.R. Co. Abandonment, 257 ICC 700).

Reasons for Proposed Abandonment: The reasons for the proposed abandonment are that the gravel deposits in the territory traversed by the line are not profitable where mining operations are no longer economically feasible and the producers have expressed no further need for the line and no objection to its abandonment. No shipments have been moved by the line since November 1974.
