### Short Course For Beef Cattle Producers Tues.

A Short Course for Beef Cattle Producers is scheduled for September 16 and 23 according to Joann Cooper, County Extension Agent. The short course will be held at the Columbus High School Cafeteria and each night's session will begin at 6:00 p.m.

At the September 16 meeting, Dr. John Beverly, Extension Reproduction Specialist, will discuss economic losses due to poor reproduction among the cow herd. Methods of improving calf crop percentages will be covered from many approaches and Beverly will utilize reproductive tracts from slaughtered cows to show what the u-born calf looks like at different stages of gestation, as well as show artificial insemination procedures.

Beverly works statewide in programs and activities directed toward improving the livestock producer's income. He has been active in the past in improved reproductive efficiency.

The second night of the short course will be held on September 23 and will cover the economics of production with a special emphasis on the program of the beef producer.

The short course is being held for all interested producers and all are invited to attend.

### Broz Asks Damages From Seismograph Test

A civil suit filed in District Court this week alleges damages to a water well owned by Otto Broz from a seismograph test and is seeking for a total of \$12,277.91 for alleged damages.

The suit is styled Otto Broz vs. M. L. Randall, Explorer Inc., Mr. Broz alleges that his water well was damaged by an exploration test made by the firm. He says it cost him \$2,277.50 to replace the well and pump and he asks for this amount plus \$10,000 in damages and \$500 for being deprived of water for his home and garden during the time the well was being tested.

Survivors include his wife; one daughter, Mrs. William Zboril of Garwood; two sons, Dr. Max Zboril of Victoria and Preston Faykus of El Campo; eight grandchildren, two brothers and three sisters.

### State Files Motor Carrier Violations

The State of Texas filed charges of violation of a motor carrier's permit in a suit filed in district court by the state against Dick Young, Jr., Leman Ray Hargrave and Frank Hiedes, individually and doing business as Hiedes Supply Co.

The suit alleges that the firm was hauling road grade material from Columbus to Krum in violation of the permit.

The suit also seeks re-issuance of the permit and a \$50 per day room rate at a cost of \$39.49. The combined cost of \$22,071 is paid by the county on the officials and employees only. The officials and employees pay for insurance on the trucks at the rate of \$32.65 per family. The last tract carried for a \$30 room rate and the \$3000 fine insurance for a total cost of \$37.09. Dependents in the past were insured at \$24.22.

Under the \$50 room rate approved by the court, the policy includes a \$60 per day major medical clause. The basic \$50 per day rate has a \$25 deductible clause one time each year, and the major medical coverage has a \$100 deductible one time per year. The major medical coverage would cover 80% of the total cost of the first \$500 (or \$2000) and then be in effect up to a maximum of \$100,000. The firm offered a \$40 room rate for \$7.99 for officials and employees and at a cost of \$30.25 for dependents.

Last year the county provided the life insurance coverage up to \$3000. The new \$6 per \$1000 rate. Also included in the contract were other provisions.

Gen. Jurys and a Mr. Lively represented the company at the bid opening and pointed out that the new coverage will include a supplement to the existing policy to provide \$300 coverage without hospitalization, and also diagnostic laboratory and X-ray up to \$50 without hospitalization required.

The county has 107 persons listed on the roll covered by the group insurance program and of these 107, fifty-five are paying for coverage for their dependents.

Judge Crawford noted that the county will be paying \$18 per year more for each employee and official covered and that the dependents will increase by \$28.50 per year. Some discussion was held on the possibility of the increased dependent coverage being assigned to this project as further meetings and a report in the near future.

### School Bd. Gets Butane Bid

The board approved the bid of Modern Fuels, Inc. of Galveston to provide butane gas for the 1975-76 year at a cost of 24.5¢ per gallon. This price will increase as the cost of the gas to the supplier is increased as substantiated by invoices to Modern Fuels. Two other bidders were Colorado County Butane, at Sheridan, bid 30.1¢ per gallon; and Schneider LPG, Inc. of Eagle Lake offered butane for 23.5¢ per gallon. They also noted prices would increase as their cost of gas increased.

The board approved use of the Garwood school grounds for the Garwood Lions Club for the community fair and carnival set for Oct. 18th.

Asst. Sept. Charles W. DeSanzo reported on progress being made by a Long-Range Planning Council established by the county to identify priorities and future projects. He noted that the planning program will be carried out in conjunction with a study for the Texas Education Agency and the Southern Association of Secondary Schools.

He said that committee work will get underway at once in the various schools of the district and these reports will come back to the Central Planning Council for review and recommendations to be made to the board, tentatively in January.

Supt. Krivacka also reported that work is continuing on a codification system for the district's policies handbook and the committee assigned to this project expects further meetings and a report in the near future.

### Some Postal Rates Going Down... Temporarily

The United States Postal Service will place in effect 1201 a.m. Sunday, September 14, 1975, the following changes in postage rates, said Postmaster Robert S. Martin.

First class letter mail will be 10 cents for the first ounce or fraction of an ounce. Each additional ounce or fraction of an ounce will be 9 cents. Pieces over 13 ounces are subject to the priority mail rate which has not changed. Postal and post cards have been reduced from 8 cents to 7 cents.

A 9-cent denomination stamp is not currently available, but the post office will save available for customers 2-cent and 7-cent stamps to use in combination with 10-cent stamps.

Seven cent postal cards will also be available. Customers will be allowed to exchange 8-cent postal cards at 100% of value for postage on a 7-cent card. To avoid problems for high volume mailers, the exchange program will not be available to customers who present mailings of 8-cent cards. The cards will be counted and 1-cent credit given for each 8-cent card. The memoranda can be applied for payment of postage or purchase of stamps when convenient.
