was an elementary school principal. She took one year of leave and taught in the Dependents' School in Frankfurt, Germany.

Because of her excellent record as teacher and administrator she was invited to teach in summer schools at both Sul Ross State College and the University of Frankfurt.

Through the years Miss McRee has participated in the activities of the Dine Rose Harris Chapter of the Daughters of the Republic of Texas and of the John Everett Chapter of the Daughters of the American Revolution. Currently she is Regent of the DAR.

Also, she is a member of the Colorado County Historical Commission and of the Christ Episcopal Church in Eagle Lake.

She is also active in the Colorado County Retired Teachers Association; Texas as Retired Teachers' Association and National Retired Teachers' Association.

Since her retirement from the teaching profession she has continued to be active in organizations that promote the best interests of education and the teachers.

In introducing Miss McRee as one of the three recipients of the Outstanding Alumni Award it was noted that "throughout her busy life, Kathryn McRee has found time to respond to invitations of the Alumni to speak on special occasions and to serve as a member of committees for student gatherings, just as she has given generously of her time, she has also given of her means to projects of the Alumni and Ex-Students Association.
