company who has worked here for a number of years: Lester Lebold; and a new outsider, Danny Young. The outside operators here and in Columbus are in control of Mike Plemmons, service foreman. Plemmons and his family live here having purchased the former Russell Cooper home on State Street.

Farris also discussed future equipment changes planned by Southwestern Bell Telephone Co. for the conversion to Electronics Switching System (ESS). "Tentative plans are to convert the Eagle Lake plant to ESS in January of 1980 and the goal is to have the entire Bell system on electronic switching by the year 2000." Farris. The switcher to ESS will greatly improve the capability of the Bell System and is expected to improve service vastly.

In conclusion Farris told the gathering that the move by the Texas Legislature to forbid charges for directory assistance calls is an "Anti-consumer" move. He noted that the average customer never exceeds the ten call maximum and when there is a charge, on those calls, the customer will eventually have to pay for the cost of directory assistance calls, over the maximum of 10, made by relatively few of the Bell customers.
