National Flood Insurance
Program Available Here

Residents of 574 Texas communities can protect themselves against losses from floods by purchasing flood insurance. This protection is available to residents and commercial property owners through the National Flood Insurance Program.

Eligible Texas communities include Eagle Lake, Colorado, Seely, Wallis, Hallockville, Wharton and La Grange in this area.

The National Flood Insurance Program is a joint venture of the federal government and private insurance companies under which flood insurance is made available to communities and areas which adopt certain land use and flood control measures.

The Federal Insurance Administration of the U.S. Department of Housing and Urban Development has determined that about 15,000 areas in the United States are "flood prone." In order to participate in the federally subsidized flood insurance program, a flood prone locality must apply to HUD for eligibility. Then, the community must adopt building ordinances which require after building standards in its flood areas.

When the area has been accepted into the "emergency" flood program (federally subsidized insurance rates), property owners are eligible to buy flood insurance.

Most people will have to plan a 15-day waiting period before the coverage takes effect. The same 15-day waiting period exists when an insured decides to drop the coverage due to lack of flood threat.

The following shows the maximum limits of "emergency" flood insurance available and the rates charged:

Single family residential (building) limit \$25,000, rate 25 cents per \$100 insurance; contents, non-residential (building) limit \$100,000, rate 40 cents per \$100 insurance; contents, residential (per unit) limit \$10,000, 35 cents per \$100 insurance; contents, non-residential limit \$100,000, 75 cents per \$100 insurance.

One of the stipulations of the National Flood Insurance Program requires the purchase of flood insurance in identified flood hazard areas of eligible communities, in connection with receiving any form of federal assistance for acquisition or construction purposes. In effect this means that flood insurance is required for purchase or construction of homes or buildings using FHA, VA or Small Business Administration loans, or loans from any federally regulated bank and savings and loan institution.

Federal Disaster Assistance should not be considered as a substitute for flood insurance. Some of the benefits of this assistance program have changed greatly over the past several years. For instance, the maximum amount on a loan has been reduced and the pay-back interest rate has increased.

Flood insurance policies can be purchased from any property-casualty agent or broker. St. Paul Fire and Marine Insurance Company has been the servicing company for the flood insurance program in Texas since January, 1977. Its flood insurance office is located at 2100 Travis Street, 9th floor, Houston 77002.
