4 From EL Injured In Wreck Last Saturday

A Needville couple was killed and four Eagle Lake residents were injured in a three-vehicle collision Saturday, March 17th on U.S. 90A at Eagle Road between East Bernard and Rosenberg in Fort Bend County.

The driver of the third vehicle, William L. Marshall of East Bernard, was not reported injured, the DPS said.

Officers said the vehicle driven by Jose Reyes was westbound on U.S. 90A and swerved into the eastbound lane to avoid hitting the rear of a stopped vehicle that was turning left and collided head-on with Sosa's vehicle. The Marshall vehicle then skidded into the Sosa vehicle, the DPS said.

It was reported Tuesday night that Danny, the most seriously injured with severe head injuries, is expected to recover but will face a long recuperation. Mrs. Sosa had two broken legs and serious internal injuries but was reported to be "holding her own" late Tuesday.

The other two injured persons are reported to be doing nicely in the respective hospitals.
