A canvass of votes in the city officers' election held April 4th, was approved by the Eagle Lake city council during its regular session on Tuesday night of last week.

All three incumbents Mike Duarte, Alvin Kohleffel and Ralph Truly were re-elected to two year terms while the only other candidate in the race, Wilfred Luedtke, was defeated. A total of 134 votes were cast in the election, two of which were abstentions.

Following swearing in ceremonies for the three councilmen, Mayor Elmer Struss announced his appointments and committees for the 1981 year.

Alvin Kohleffel, a 30 year veteran of the council, was appointed Mayor Pro-Tem by Struss with Gene Baker being appointed treasurer and Ralph Truly appointed as the council's representative to the library board.
