Extortion Charged In Bomb Threats

on the Citizen's line. A short time later another call was received stating that another call would give details on how and where to pay the \$5,000.

Meanwhile, the Colorado County Federal Savings and Loan Association office and possibly other places, also received calls from a man, believed to be the same caller to the Citizen office, asking for money or a bomb would be set off there.

At around 3 p.m. the man called the Citizen office again and the trace indicated the call came from the Sonic Drive-In and Wine and Citizen reporter Andy Heines and other officers rushed to the drive-in and confronted the manager Doug Kipl, 24. He denied making the calls at first, but after Wine took him outside and read him his rights, notifying Kipl that his voice was recognized, in the presence of other officers, Kipl reportedly admitted making calls to the Citizen and the loan office. He contended, however, that the call about the poisoning was a prank call.

Coincidentally, Kipl came to Columbus from Oklahoma (where Belcher was born) and he lives in the same apartment complex and on the same floor as did the newspaper publisher. Columbus officers said that Kipl is under an 18 month term of probation on a previous \$2,000 extortion charge in Oklahoma.

He was placed in the county jail under the charge of extortion, under \$50,000 bond, pending further investigation of the cases.

Because of the developments Tuesday, J.P. Schmidt

decided to approve an autopsy to be made in Houston to ascertain the cause of Belcher's death. However, Chief Wine said late Tuesday that no evidence had been obtained at that time to indicate that Belcher did not die of natural causes as originally ruled by J.P. Schmidt.
