The project will increase the hospital's capacity from 37 to 47 beds and will include addition of a therapy department and a new surgical recovery room and other improvements to the existing facilities.

Thomas R. Fannin of the architectural firm of Page Southerland Page of Houston is the project manager.

Eagle Lake Community Hospital was initially granted a license to construct a 37 bed hospital in 1973 and the official dedication of the \$1,550,000 facility was held debt free on Mar, 23, 1975.

The new wing will extend southeast and perpendicular to the present facility (toward the Heritage House) and will join the present facility near the present

nurses' station. The expansion will add a total of 3,700 square feet to the existing facility which has around 30,000 square feet. Costs of the expansion have been estimated at around
