Reserve Officer Dan Easter and Chief Gil Steen responded to a call from Meraldo Berroa of Eagle Lake last Saturday at 7:45 p.m. and found two men fighting, according to a report. Berroa had called to complain that Rolando Perez Guzman had come to his apartment to borrow some money. When he was refused, Guzman grabbed some money that was on a table and ran out with it. Berroa caught him outside and the two began to fight.

Police called for an ambulance to take Guzman, suffering from cuts above his eye and the back of his head, to the Eagle Lake Community Hospital. Guzman became angry and resisted the attendants, and was taken to the hospital in a squad car.

At the hospital, Chief Steen removed \$65 from Guzman's pocket and marked it for evidence, the amount taken from Berroa. Guzman was treated and released to police. He was taken to County Jail and bond was set at \$2,000.
