ORDINANCE NO. 83-08

AN ORDINANCE PROHIBITING THE DISCHARGE OF WEAPONS OR FIREARMS WITHIN THE CITY OF EAGLE LAKE, TEXAS, PROVIDING FOR CERTAIN EXEMPTIONS; ESTABLISHING A LICENSE PROCEDURE; AND PROVIDING FOR A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EAGLE LAKE, TEXAS:

SECTION 1: It shall be unlawful for any person to discharge any gun, pistol, or firearm of any kind or to discharge any rifle or air pistol of any description without ever name known either by means of compressed air, compressed gas, pumps, or any other means capable of discharging shots, pellets or any solid object at any velocity in excess of three hundred (300) feet per second, or to discharge any cannon cracker or torpedo within the corporate limits of the City, or within one hundred (100) yards of any house within the City.

SECTION 2: Section 1 shall not apply, however, to persons discharging guns, rifles, pistols, or firearms on premises duly licensed as a pistol, rifle, or shotgun range by the City.

SECTION 3: Any non-profit organization desiring to have premises or property licensed as a pistol, rifle, or shotgun range within the corporate limits of the City, and desiring to operate such premises as a rifle, pistol, or shotgun range, shall make application to the City and shall file the same with the City Manager not less than 10 (10) days prior to the time when it is desired to begin operations of such property or premises as a pistol, rifle, or shotgun range. Such application shall state the name and address of the organization desiring to operate such property or premises, the times of operations, and other information deemed necessary by the City Manager. At a minimum, the organization shall assure that the following criteria have been satisfied:

SECTION 4: Any person, firm, individual, or organization who shall violate any of the provisions of this ordinance shall be guilty of a misdemeanor, and upon conviction shall be fined any sum not exceeding two hundred dollars (\$200.00), and each and every day's violation shall constitute a separate and distinct offense.

SECTION 5: If any part of this ordinance is held invalid for any reason, then that part shall not invalidate the entire ordinance, but the balance thereof shall remain in full force and effect.

SECTION 6: This ordinance shall be in full force and effect from and after its passage, approval, recording, and publication as provided by law.
