

Bryant, Pugh exchange vows

Miss Leigh Ann Bryant of Lake Jackson and William "Chuck" Pugh of Houston were united in holy matrimony at 4 o'clock in the afternoon Saturday, April 14, 1984 at the First Baptist Church in Lake Jackson. Rev. Claude Johnson, pastor of Assembly of God Church in Freeport, officiated at the wedding.

The bride is the daughter of Mr. and Mrs. Richard Bryant of Lake Jackson and Eagle Lake and the groom's mother is Mrs. Faye Pugh of Houston.

An archway covered in greenery with a unity candle in the middle adorned the center of the altar. Spiral candelabra and large cascades of white gladioli with several shades of peach roses embellished by green fern giving a garden effect flanked each side of the archway.

The bride, given in marriage by her father, wore a princess silhouette gown of white French organza designed with a portrait neckline trimmed in seed pearls. Her Victorian sleeves fell to tapered cuffs. The traditional gown was trimmed with Chantilly lace on the neck and hemline and heavily beaded with seed pearl design. The chapel train fell from a matching band of lace. The bride's fingertip length veil of white illusion was trimmed in seed pearls and secured by a capulet heavily designed with seed pearls.

To complement her attire, she carried, as her bouquet, a small white Bible covered in satin and trimmed with pearls. The Bible had been carried by her mother when she was married. 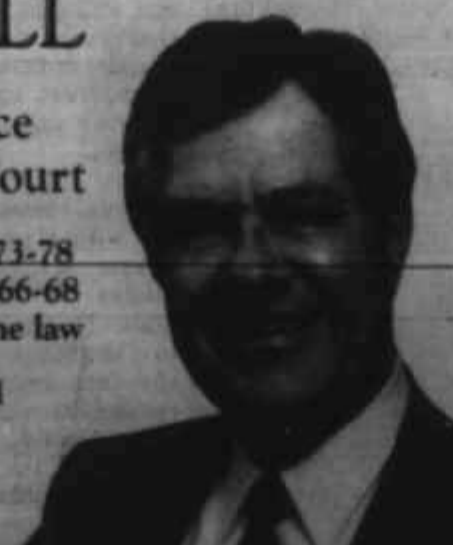
