NOTICE OF RATE CHANGE REQUEST AND STATEMENT OF INTENT

Notice is hereby given that WHARTON COUNTY ELECTRIC COOPERATIVE, INC. (the "Utility") intends to change rates for electric utility service effective February 18, 1986. Based upon a 12-month period ending June 30, 1985, the Utility had adjusted test year revenues of \$7,676,043. The Utility proposes to increase revenue \$299,999 or 3.95% above adjusted test year revenues. Adjustments to test year revenues in the amount of \$147,686 reflect the reconciliation of power cost revenues and expenses as well as revenues required to offset increased power cost which the Utility already has authority to collect. Actual test year revenues were \$7,528,357. The increases requested over actual test year revenues is \$1,447,686 or 19.6%.

The changes are applicable to all areas and all customers served by the Utility. The classes and numbers of Utility customers affected are as follows:
