NOTICE OF APPLICATION FOR WASTE

DISCHARGE PERMIT RENEWAL

Colorado County W.C.D. No. 2, P.O. Box 317, Garwood, Texas 77442 has applied to the Texas Water Commission for renewal of Permit No. 10152-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 100,000 gallons per day from the wastewater treatment facilities which are located approximately 25 feet east of the intersection of Mansfield and Wirtz Streets in the City of Garwood in Colorado County, Texas. The effluent is discharged into a drainage ditch adjacent to the canal side, thence to the Colorado River in Segment No. 1402 of the Colorado River Basin.

The Executive Director of the Texas Water Commission has prepared a draft permit which, if approved by the Commission, will specify conditions and limitations generally the same as those currently enforced by the existing permit. The expiration date of the existing permit was October 13, 1986. It is proposed that the expiration date be specified as midnight, five years after date of Commission approval.

Legal Authority: Section 26.028 of the Texas Water Code, as amended, and 31 TAC Chapter 305 of the Rules of the Texas Water Commission.

No public hearing will be held on this application unless an affected person who has received notice of the application has requested a public hearing. Any such request for a public hearing shall be in writing and contain (1) the name, mailing address and phone number of the person making the request; and (2) a brief description of how the requester, or persons represented by the requester, would be adversely affected by the granting of the application. If the Commission determines that the request sets out an issue which is relevant to the permit decision, or that a public hearing, would be in the public interest, the Commission shall conduct a public hearing, after the issuance of proper and timely notice of the hearing. If no request is received for a hearing is received within 30 days of the date of publication of the notice concerning the application, the permit will be submitted to the Commission for final decision on the applications.

Requests for a public hearing and/or requests for further information concerning any aspect of the application should be submitted in writing to Michael E.
