

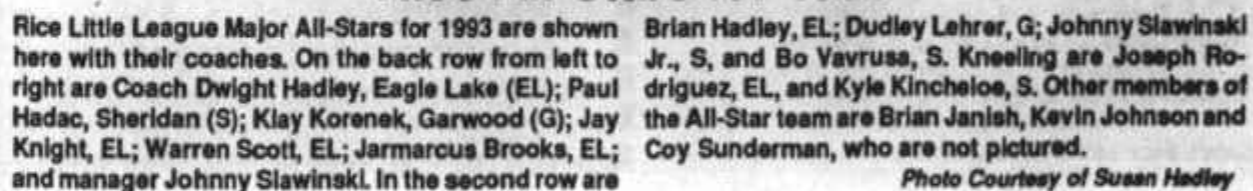

Adult Red Cross swimming lessons will be offered at the Eagle Lake Community Pool Mondays, Tuesdays and Thursdays for two weeks beginning Aug. 2 through 12.

Courses will be offered for beginners and advanced beginners from 7:30 to 8:30 p.m.

The lessons are free but there is a \$7 pool charge per participant.

During this season of increased activity and outdoor fun, it is especially important to be aware of a few basics in the area of foot and ankle injuries. One of the most common mistakes people make is to soak an injury in hot water. This actually increases swelling and pain by stimulating blood flow to the area. Always elevate the foot and apply ice wrapped in a cloth as soon as possible after injury, and then seek professional help. Contrary to popular belief, the fact that someone can still move a foot or even walk on it following an injury does NOT automatically mean it isn't broken. Toe fractures in particular are often ignored because people believe that treatment isn't necessary.

Always keep a small ice pack in the freezer, not just for the cooler, but for sudden injuries.
