other areas.

The rash usually fades in one to two weeks, but it may recur two to four weeks later, brought on by exposure to sunlight, exercise, heat or emotional stress.

Sufferers may also experience mild joint pain for a couple of months.

Like Rubella, Fifth Disease can be passed on to the unborn child transplacentally, causing problems with development. However, this is relatively rare and the frequencies of such occurrences is still unknown.

Pregnant women exposed to Fifth Disease should advise their doctor.

Since Fifth Disease is viral, not bacterial, antibiotics are not an effective treatment. Symptoms can be treated with acetaminophen (Tylenol).

To prevent the spread of Fifth Disease, student, teachers and families should practice proper hand washing and make sure tissues are disposed of in a sanitary manner.

And, while Fifth Disease may not seem to be a serious illness, a child should be examined by his/her family doctor to confirm the diagnosis or to rule out other illness.
