NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION

NOTICE is hereby given that it is the intention of the City Council (the "City Council") of the City of Eagle Lake, Texas (the "City") to adopt an Ordinance providing for the issuance of interest-bearing revenue obligations of the City presently contemplated to be designated and known as the "CITY OF EAGLE LAKE, TEXAS COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION, SERIES 1997" (the "Certificates of Obligation") for the purpose of providing financing for street and drainage improvements and of the payment of contractual obligations for professional services in connection therewith (including, but not limited to, architectural, financial advisory, legal, and engineering). The City Council tentatively proposes to authorize the issuance of the Certificates of Obligation at its regular meeting place in the City Hall, Eagle Lake, Texas, at a meeting of the City Council to be commenced at 7:30 p.m., on the 10th day of June, 1997, in an amount expected not to exceed \$1,000,000.00. The City Council proposes to provide for payment of the Certificates of Obligation from a pledge of an annual ad valorem tax and \$1,000 of the surplus revenues of the City's waterworks and sewer system.
