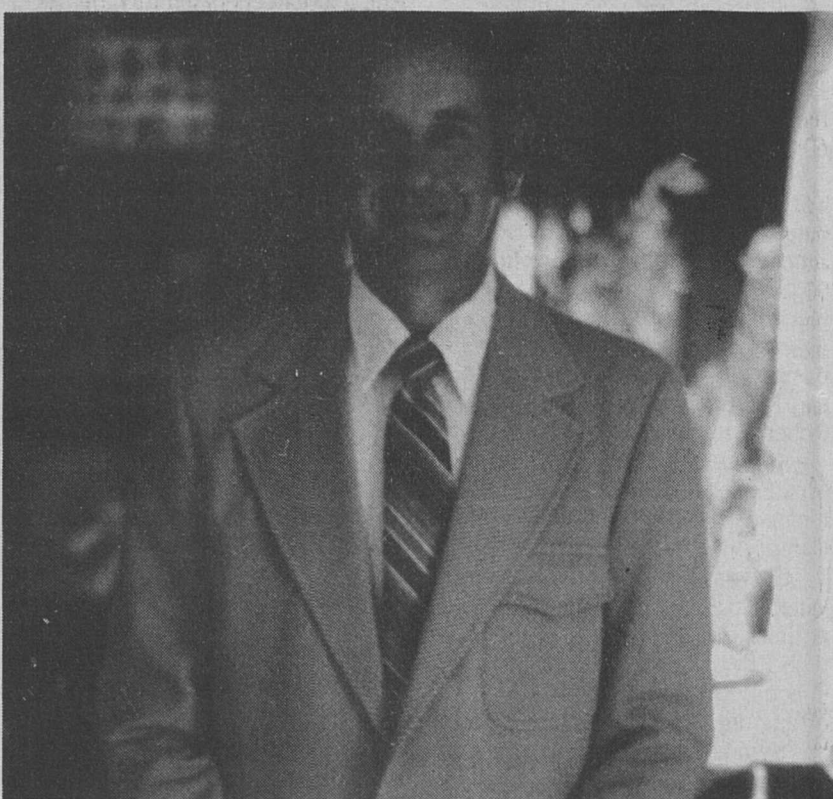


COLORADO COUNTY COURTHOUSE REPORT

Foot Facts

YOUR FEET SHOULDN'T HURT

Feet are the Rodney Dangerfield of the body; too often, they "don't get no respect." As we age, that abuse can add up to painful results. The good news is that foot should not - and need not - hurt. If yours do, the first step toward stopping the pain is a podiatric exam. Because foot problems are often related to conditions in other parts of the body, such visits generally begin with a total medical history, including questions about any medications you may be taking. The feet's pulses, temperature, flexibility, and skin color will also be checked. Tests that may be done to diagnose particular problems include X-rays, magnetic resonance imaging, computed tomography, Doppler (sound wave) tests, and blood tests.

Listen to your feet. They often have lots of things to tell you, such as giving you clues about the rest of your body's well-being. When your feet tell you there's trouble, as your podiatrist, we'll work as a team with you, and other health care providers if appropriate, to keep you and your feet healthy and pain-free.
