- 1) Installation of carpet and floor repair in the Courthouse, and

Bidder for the installation of carpet and floor repair in the Courthouse shall include in its bid proof of Workers' Compensation Insurance and General Liability Insurance Coverage in the amount of one million dollars (\$1,000,000).
