New Antibiotics for Resistant Bacteria

The worldwide emergence of resistant strains of potentially deadly bacteria has created a significant challenge to physicians everywhere. Treatment failures from the use of traditional antibiotics has been well documented. The only antibiotic available for many years for resistant bacteria was vancomycin (Vancocin). Recently, newer antibiotics have been approved to address the growing problem of bacterial resistance.

Two new "quinolone antibiotics" (gatifloxacin, and moxifloxacin) appear to be effective against resistant bacteria such as *Streptococcus pneumoniae*. This same bacteria often is resistant to penicillin, erythromycin and the large family of antibiotics called the "cephalosporins." Moxifloxacin (Avelox) is approved for the treatment of bronchitis, sinusitis, and pneumonia. Gatifloxacin (Tequin) is acceptable for the same infections, and it also is approved for urinary tract infections. Another promising new antibiotic that works differently than the quinolones is linezolid (Zyvox). It has been shown to be effective against *Staphylococcus* and *Enterococci*, bacteria that often cause resistance problems.
