House fire claims lives of four children

Shortly after 10 p.m. the evening of Thursday, Dec. 14, the Colorado County Sheriff's Office (CCSO) received a 9-1-1 call reporting a house

fire on County Road 271 and Washington Street in Oakland.

The Oakland and Weimar fire departments were dispatched to the

scene and found the home fully engulfed.

They were informed that four children were believed to be trapped inside the burning structure.

The children's mother, Candice Booker, 27, and a son, Tyndell Booker, 11, were able to escape through a window.

After distinguishing the blaze, firefighters recovered the bodies of four children. Killed were Ladeserien Sidney, seven years, 11 months old; Jameka Booker, seven years old;

Sheniqua Booker, six years old; and Darius Sidney, five years old.

The two survivors were taken to Colorado-Fayette Medical Center in Weimar for treatment.

The cause of the fire had not been determined at the time of this report.

The State Fire Marshall's Office, Railroad Commission and CCSO are conducting the investigation into the cause of the fire.

Autopsies were ordered by Pct. 2 Justice of the Peace Ed Hanzelka on the victims.

State enlists Santa's help in annual campaign

Santa Claus is warning Texas drivers: He's not the only one watching to see if they're good or bad.

All available state troopers will be on the roads during Christmas and New Year's holiday weekends watching for drunk drivers. Police and sheriff's departments throughout Texas also are stepping up DWI enforcement efforts. Penalties for driving while intoxicated can include license suspension, fines and jail time.

State transportation officials are joining forces with Mothers Against Drunk Drivers and the food and beverage industry to enlist Santa's help in the Texas Dept. of Transportation's annual statewide campaign reminding Texans not to drink and drive during the holiday season. Last Dec., 83 people were killed and 2,303 injured in alcohol-related accidents in Texas.

"If alcohol is involved in their holiday celebrations, we're reminding people not to get behind the wheel if they've been drinking," said Susan

Bryant, traffic safety director for the Texas Department of Transportation. "Safe alternatives are to designate a sober driver before drinking begins, call a taxi or just stay where you are until you can drive home safely."

Texas leads the nation in alcohol related traffic crashes. In 1998, the Texas Dept. of Public Safety reported there were more than 26,000 alcohol-related crashes in Texas, resulting in 1,058 fatalities and 27,058 injuries.

The state's campaign again features the slogan "Santa Is Coming To Town. Please Don't Hit Him. Don't Drink and Drive." Billboards, ads atop gas pumps and TV and radio commercials echo the safe driving message.

Helpers in the campaign include the Texas Alcoholic Beverage Commission, Texas Petroleum Marketers & Convenience Store Association, Texas Package Stores Association, Texas Restaurant Association, Diamond Shamrock and Mothers Against Drunk Driving.

The Eagle Lake Police Department (ELPD) reported the following calls and cases for the week ending Dec. 18.

Webb was dispatched to the Eagle Lake Supermarket located at 200 S. McCarty in reference to an individual attempting to pass a check that was written on a closed bank account.

Chief Webb met with a young man who identified himself as Douglas Tillman of Eagle Lake and with a female who identified herself as Leanne Tennyson of Columbus.

Tennyson's personal check was being questioned as being "good" after it had been presented to the store by Tillman. The manager of the store, Jensani, stated the store had already taken a check from Tennyson and it had been returned as being on a closed account. That check had been turned over to the county attorney.

Chief Webb is investigating this attempted passing of a bad check.

From 2 to 6 p.m., Sgt. Bill Lattimore and Officer Stephen Nelson arrested Robert Earl Black, Gloria Snavely, Christal Smith and Sheila Katerling at several locations in Eagle Lake on outstanding warrants for motion to revoke probation. All four subjects were processed at the ELPD and transported to the CCDC for confinement.

On Dec. 16, at 1:30 p.m., Officer Nelson was dispatched to a theft call at 619 Fairview St. The victim stated that someone took an aerobic machine and a laundry shelf from her porch. The items were mail ordered and had been delivered by the Post Office. The suspect(s) apparently stole the items from the porch after they had been delivered.

On Dec. 17, at 3:16 p.m., Officer Nelson was dispatched to a juvenile disturbance at 506 Clay St. He handled the situation at the scene.

At 4:12 p.m., Officer Nelson and Sgt. Lattimore were dispatched to a traffic accident in the 800 block of S. McCarty. Dan Canaris was driving north bound in the 800 block of S. The ELPD had been requested to investigate this accident due to the Department of Public Safety and county deputies being too busy to do so.
