Back to school tips for bicycle safety

With classes in area schools already underway, Sally Garrett, Colorado County Extension Agent for Family & Consumer Sciences, said many of youth will be riding their bicycles to and from school and need to be reminded about Texas laws and how to ride safely.

Here are some tips to ensure children ride safely:
•**In Texas, a bicycle rider is a vehicle operator: It's the law!** Cyclists must obey all traffic signs and signals and if riding in the road one must act as if operating a motor vehicle. That means signaling all turns with hand or arm signals.

•**Headlight and rear reflector for riding at night: It's the law!** Bicycle riders who ride after dark must have a white headlight and rear red reflector. Many of the crashes which occur at night are caused by cyclists who aren't seen by other vehicle operators. If there is no light, a rider cannot be seen until in the headlights of the other vehicle.

•**Ride in the same direction as other traffic: It is the law!** Even on the sidewalk, cyclists should go in the same direction as the other traffic on the road. Most drivers don't see cyclists on the sidewalk, especially those going the wrong way.

•**One rider per saddle: It's the law!** Most bicycles are designed to be ridden by one person and become unsafe when more than one rider is present. That means no hitching a ride on the handlebars, top tube or pegs on the axle.

•**Always stop before entering traffic:** This is especially important where drivers are not expecting bicycles. Many young riders dart out of

Reliant Energy-Entex cuts natural gas prices

Reliant Energy-Entex announced natural gas bills will be lower for customers in the South Texas area this winter due to lower wholesale gas prices.

Decreasing the gas cost adjustment will lower the average residential winter gas bill using 100 cubic feet

of natural gas by about 25%. The decrease will appear on customer bills beginning in Aug.

Thomas retiring after years as J.P. 4 Clerk

Due to the pending retirement of Phyllis Thomas, Chief Clerk of Justice Court Pct. 4 in Eagle Lake in Oct., an employment opportunity has become available.

The person filling the position will hold the title of part-time clerk with pay being \$7.79 an hour, and approximately 32 hours per week.

A County Retirement Benefit is included but paid vacation/sick leave and medical insurance are not.

Those interested may pick up an application at the Pct. 4 Justice Court office at 100 E. Main St., Eagle Lake.

Important responsibilities and duties may include, but are not limited to, the following: coordinate all telephone communications within the office; type and prepare a variety of correspondence and legal documents which may include warrants, bond forfeitures and dockets for the court; assist the public with paperwork; explain state and county policies and procedures; index and file legal documents; correspondence and reports; perform a variety of responsible and confidential secretarial and administrative duties including the maintenance of various records; make bank deposits; sort and distribute incoming mail; deliver documents to courthouse and other legal offices in the county;

Also, interpret and explain county policies, procedures, laws and regulations in response to public inquiries and complaints; refer inquiries as appropriate; over see all phases of civil procedure reports, appeals and transcripts; schedule all civil and criminal hearings; notify plaintiffs, defendants and attorneys of court settings; prepare judgments; monitor civil cases; process the collection of insufficient fund checks for merchants including issuance of warrant; serve as Deputy Local Registrar of Birth and Death records; perform other duties as assigned; and travel to and attend continuing education seminars as may be necessary for Court Clerk and State Registrar certification(s).

Qualifications for this important position include a high school diploma or equivalent; basic knowledge of modern office procedures, methods, computer programs and equipment; basic knowledge of business letter writing and report preparation; basic knowledge of principles and procedures of record keeping and reporting and the ability to work independently in the absence of supervision. Being bi-lingual is a plus.
