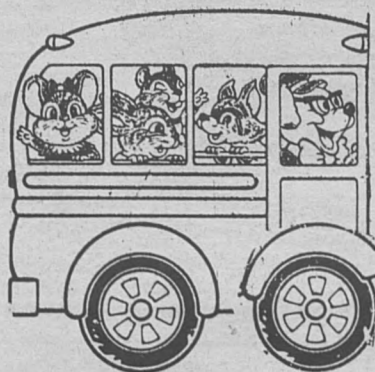

Barbecue Cookoff

The fourth annual Colorado County Cookers Association Barbecue Cook-Off will be held Saturday, September 15, in conjunction with the Colorado County Fair at the new Ag Complex grounds located on the Highway 71 Bypass near Columbus. Check in times will be Friday, September 14, from 3 p.m. till 8 p.m. and Saturday, September 15, from 6 a.m. till 12 noon. Categories of competition are brisket, pork ribs, chicken and beans. Entry fees are \$15 for each category or \$50 to enter all categories. Judging will be held Saturday afternoon at the following times: chicken 4 p.m., beans 4:30 p.m., pork ribs 5 p.m. and brisket 6 p.m.

Entries may be submitted in advance, but entries will also be

accepted at the gate until 12 noon on Saturday, September 15.

Motor homes and travel trailers are welcome. No water or electric hookups are available.

All cookers and team members will be eligible for a drawing for a new barbecue pit.
