These dates and locations are listed in the official Colorado County Fair catalog available at many locations in the county. In some cases a pre-entry card must be turned in. Each Western Art entry is awarded a blue, red or white ribbon. From each of the 3 divisions (elementary, junior high, and high school) a large best of show and reserve best of show rosette ribbon will be awarded. In addition several finalist rosette ribbons will be awarded depending on the number of entries. If your school is not involved talk to your teacher about participation or enter as an individual. See the fair catalog.

The Fine Art division is open to all ages. Artwork covering any subject is accepted, unlike the western art division, which accepts art of a "western" subject only. A pre-entry card must be turned in. Please see the fair catalog for details
