NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR WATER QUALITY TPDES PERMIT RENEWAL FOR MUNICIPAL WASTEWATER

PERMIT NO. WQ0010505001

APPLICATION AND PRELIMINARY DECISION. City of Eagle Lake, P.O. Box 38, Eagle Lake, Texas 77434-0038, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of TPDES Permit No. 10505-001, which authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 750,000 gallons per day. This application was submitted to the TCEQ on June 8, 2004.

The facility is located approximately 400 feet southeast of the intersection of U.S. Highway 90A bypass and McCarty Avenue, being also 0.5 mile northwest of the intersection of Farm-to-Market Road 102 and U.S. Highway 90A in Colorado County, Texas. The treated effluent is discharged to a drainage ditch; thence to Eagle Lake; thence to an unnamed tributary; thence to the Colorado River Below La Grange in Segment No. 1402 of the Colorado River Basin. The unclassified receiving water uses are no significant aquatic life uses for the drainage ditch, high aquatic life uses for Eagle Lake are limited aquatic life uses for the unnamed tributary. The designated uses for Segment No. 1402 are high aquatic life uses, public water supply and contact reaction.

The TCEQ executive director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The executive director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, statement of basis/technical summary and executive director's preliminary decision, and draft permit are available for viewing and copying at the Eagle Lake City Hall, 100 East Main Street, Eagle Lake, Texas.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

Written public comments and requests for a public meeting should be submitted to the Office of the Chief Clerk, MC 105, TCEQ, P.O. Box 13087, Austin, TX 78711-3087 within 30 days of the date of newspaper publication of the notice.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant material, or significant public comments. The response to comments, along with the executive director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the executive director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on issues that were raised during the public comment period and not withdrawn. Issues that are not raised in public comments may not be considered during a hearing. The TCEQ may act on this application to renew a permit without providing an opportunity for a contested case hearing if certain criteria are met.

EXECUTIVE DIRECTOR ACTION. The executive director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the executive director will not issue final approval of the permit and will forward the application and requests to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. In addition to submitting public comments, you may ask to be placed on a mailing list to receive future public notices mailed by the Office of the Chief Clerk. You may request to be added to: (1) the mailing list for this specific application; (2) the permanent mailing list for a specific applicant name and permit number; and/or (3) the permanent mailing list for a specific county. Clearly specify which mailing list(s) to which you wish to be added and send your request to the TCEQ Office of the Chief Clerk at the address above. Unless you otherwise specify

you will be included only on the mailing list for this specific application.
