## Attorney General Abbott Lodges Clawback Complaint

AUSTIN — Texas and other states on March 3 filed suit against the U.S. Department of Health and Human Services over how states are forced to fund the new federal prescription drug benefit.

Attorney General Greg Abbott, on behalf of Texas, Kentucky, Maine, New Jersey, and Missouri, presented the U.S. Supreme Court with a complaint about the requirement that states pay a portion of the costs as-

sociated with federal Medicare drug coverage for persons eligible for both Medicare and Medicaid.

Abbott questioned the constitutionality of annual "clawback" payments — money states must send each month to the federal government to compensate for savings Congress anticipates states will realize from no longer providing prescription drug coverage for individuals enrolled in Medicaid.

The program is projected to result in net losses to Texas of approximately \$100 million from 2006-2009.

## Texas Lottery drops bonus ball

After soliciting public comments on how to shore up sagging participation in Lotto Texas the Texas Lottery Commission on Feb. 27 jettisoned the bonus ball.

The commission revised the game, which debuts April 23, so that players will pick six numbers from a field of 54.

"While there may not be an immediate and magic fix to the decline of our Lotto Texas game," said Lottery Commission Chairman C. Thomas Clowe, "I feel it's our responsibility to take action today to remove the one feature we've heard players disapprove of the most, the bonus-ball feature, and change Lotto Texas back to a pick-six game."

Without the bonus ball, the odds of winning the jackpot will be one in 25.8 million and overall odds of winning any prize will be one in 71, the agency said.

## Court hears redistricting case

The U.S. Supreme Court on March 1 heard arguments in the Texas redistricting case relating to the November 2004 election and the dynamics that set the stage for a shift from a 17-15 seat majority for Democrats to a 21-16 seat majority for Republicans.

Attorneys for Mexican-American and African-American plaintiffs said the Texas Legislature violated the federal Voting Rights Act by watering down communities of interest and thus, voting power, in moving district lines.

Furthermore, attorneys for Democratic state legislators said it was unprecedented for district boundaries to be redrawn in the middle of a decade. Federal law requires redistricting after the U.S. Census is taken every 10 years, at the beginning of each decade.

In its defense, the state of Texas argued that it is the Legislature's privilege and legal responsibility to redraw districts when the collective will exists.

The court is expected to render a

decision on the case before its term ends in June.

The award recognizes the counties for having the highest percentage of voter turnout in the November constitutional amendment election.


King County's 54 percent was the highest voter turnout for small counties and Travis County won the large county group with 25 percent.

## needed to jointly finance the purchase of the farm, the interest rate on the FSA direct loan would be fixed at five (5.000%) percent.

SDA loan applicants do not receive automatic approval. Individuals must be U.S. citizens with a satisfactory history of meeting credit obligations, have sufficient education, training or experience managing or operating a farm, possess the legal capacity to incur debt, and be unable to obtain credit through traditional lending means.

Qualified loan candidates are provided information and assistance to develop sound management practices, analyze problems and utilize available resources essential for successful farming in the ever-changing agricultural environment," said Respondak.

## FSA Allocates Loan Funds For Disadvantaged Farmers

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) allocates a portion of its farm loan program funds specifically for socially disadvantaged applicants (SDA) including minority and women

producers.

"FSA farm loans are available to all qualified applicants, but by setting aside funds specifically for minorities and women, the Agency ensures members of these specific groups can receive a portion of available funds — assuming they meet FSA loan eligibility requirements," said Tim Respondak, Farm Loan Manager for Colorado County FSA.

By FSA definition, an applicant is considered socially disadvantaged if he or she is a member of a group whose members have been subjected to racial, ethnic, or gender prejudice, without regard to individual qualities. FSA has identified socially disadvantaged groups as Women, Blacks, American Indians, Alaskan Natives, Hispanics, Asians, and Pacific Islanders.

FSA offers both direct and guaranteed farm loans. Farm loan funds can be used to purchase farms, livestock and equipment. They may also be used to operate a farm, build or repair ser-

vice buildings, pay for soil and water conservation practices, and in some cases refinance debt.

For direct loans made by FSA to purchase a farm the terms may extend to 40 years with a current interest rate of five and one eighth (5.1250%) percent. Direct operating loans may be made for one to seven years with a current interest rate of four and seven eighths (4.8750%) percent, which is subject to change.

"Applicants requesting direct real estate loans should be aware that funding for this program is limited and may require a waiting period before funds are available and applications approved," said Respondak.

FSA guaranteed loans are made by banks or other commercial lenders and are guaranteed by FSA for up to 90 percent of any loss. The guaranteed loan program includes both operating and real estate loan programs. If a loan applicant is able to obtain financing from a private lender equal to 50 percent or more of the total funds
