## Colorado County Commissioners Vote To Transfer Alleyton Water To LCRA

Colorado County commissioners, meeting Monday, agreed to transfer the Alleyton water and waste water treatments to the Lower Colorado River Authority (LCRA).

The LCRA has been contracting with the county to operate the waste

water treatment plant.

The waste water treatment plant has been operating since 1996.

Water lines from the water treatment plant are nearly complete.

Water service should be available in about a month, County Judge Al

Jamison said.

There are approximately 80 water meters for customers.

Jamison said the water project had been in planning and construction for the past three years.

As part of the change in ownership, there will be an adjustment in the fees for waste water service.

Residential rates will increase from \$22 a month to \$30 a month. Commercial rates will be unchanged.

The rates for water service will be \$32.50 a month for a minimum of 3,000 gallons, with a charge of \$2.50 for each 1,000 gallons over that amount.

There will be a six-month transition period before LCRA takes over ownership of the water and waste water system.

In other action, commissioners approved an upgrade and major overhaul of the existing elevator in the courthouse by Otis Elevator Co. for \$47,935.

Jamison said the commissioners did not have to seek competitive bids because the elevator is made by Otis. He said the controls would be replaced with new electronic ones.

Jamison said the elevator was installed in the 1970s and was expected to have a useful life of about 20 years. He said it has frequently been repaired in recent years.

## Candidates File For Local Offices

Five candidates have filed for election to the Rice C.I.S.D. Board of Trustees and three for City of Eagle Lake offices.

The Rice Board of Trustees will have one contested race, for Position 1.

Wayne Bowen, Carlos Gonzalez and Ed Holland will vie for this spot.

Tanya Wiese currently sits in Position 1, but has not been able to attend meetings in some time due to work and will not seek reelection.

Vivian Spanihel will be unopposed for reelection to Position 2.

Laurel Milentz will not seek reelection to Position 3.

N. Clark Peterson has filed for election to Position 3 and will be unopposed.

## Rice CISD Board Of Trustees Votes To Add Pre-Algebra Class At High School

The Rice School Board voted Monday night to add a pre-algebra class to the High School curriculum.

Math teacher Robin Machac addressed the board Monday night to discuss adding the class at the high school as well as making the prerequisites for taking pre-algebra and algebra in junior high tougher.

Machac explained that too many kids are not ready for algebra when they get to high school and this is the lowest level class that is currently offered.

Under the plan, any child that does not make at least a 70 on the math portion of the TAKS test and pass their eighth grade math class with an 80 would be required to take pre-algebra in the ninth grade.

Machac advised that there were kids passing the TAKS, which only requires a 54, and their math class, but were still not properly prepared for regular algebra.

Machac also recommended stricter requirements for pre-algebra and algebra in the seventh and eighth grade.

In order to take pre-algebra in the seventh grade a student must make an 80 in their previous math class and

to take algebra in the eighth grade the student must make at least an 80 in pre-algebra.

Machac advised that there would probably be between 30 and 40 stu-

dents who would be required to take pre-algebra in the ninth grade.

The pre-algebra class will count
