only for local credit, but will still allow time for students to receive the state-required three credits to graduate.

After some discussion a motion was made to create the class in high school and adopt the stricter requisites for the junior high.

In other board action:

-Trustees discussed the purchase of an old house in Garwood that is adjacent to the school and agreed to resubmit a bid of \$10,000 to purchase the property since no response had been received after a first submission. The district plans to clean the lot as the

-Trustees voted to move Colorado County Fair Day on the 2006-2007 school calendar from September 8 to the 15.

-Trustees agreed to purchase various breakfast food items for Teacher Appreciation Week April 7-13.

-Trustees gave authorization to lower the opening bid on a property being auctioned to pay back taxes owed by Arnold Feed Store. The opening bid will be lowered to \$50,000.

-Trustees voted to change the calculation of the honor roll to be based on a grade average as opposed to the grade-point scale. Students earning over a 90 percent would be eligible for the honor roll.

-Trustees were made aware of a situation regarding special needs students in the district. Superintendent Mike Lanier informed the board that it is becoming increasingly costly to transport the students to campuses that have the proper facilities. He advised that the size and nature of the district make it very difficult from a logistics standpoint to coordinate these efforts and that something would need to be done in the near future. He said that at the moment he did not have much of an idea on how to improve the situation, but said that he knew a solution could be found, but it was going to take some work.

installed. PAPI stands for precision approach path indicator and is a system of lights that help guide pilots monitor their flight-path when preparing to land.

Also in 2005, a new taxiway and parking apron were constructed as well as renovations done on the runway including new striping.

A more efficient drainage system has also been installed at the airport.

Current services available at the airport include three types of fuel, AVGAS, Jet A, and MOGAS. Parts, hardware and aircraft supplies are available and there is a Rotex Engine service center on site.

Flight training is also available.

The presentation also included future plans at the airport.

Among them are, widening the runway to 75 feet and lengthening it to 5,000 feet.

The committee would also like to see a permanent terminal building as well as additional hangars.
