### Sheridan holding Kindergarten registration

Sheridan Elementary and Jr. High School is registering students for the 2006-2007 Kindergarten class. To register, go to the school office and fill out registration forms. Return the forms with a copy of shot record, social security card and birth certificate. These documents are required by Texas Education Agency. If you don't have a copy you must obtain a duplicate. Students must be 5 years old as of Sept. 1, 2006 and live in the Sheridan School attendance zone. If you live out of the Rice CISD you must apply for an Out-Of-District transfer by May 1, 2006. The Rice School Board will approve or deny transfers. The Kindergarten teacher will assign a date for you and your child to visit her classroom, she will notify you by mail. ### Sheridan School taking Pre-K Applications

Sheridan Elementary and Jr. High School is accepting applications for the Pre-Kindergarten class for the 2006-2007 school year. Qualified applicants will be accepted based on Texas Education Agency and Rice CISD guidelines. Applications are available in the school office. Return the application forms with a copy of shot record, birth certificate and social security card by April 7, 2006. These documents are required by Texas Education Agency, if you don't have copies you must obtain duplicates. All applicants must be 4 yrs. old by Sept. 1, 2006 and reside within the Sheridan School attendance zone. You will be notified of acceptance or denial. If you live out of the Rice CISD you must apply for an Out-Of-District transfer by May 1, 2006. The Rice School Board will approve or deny transfers. If you have questions, call the school office 979-234-7334.

## Run-off Early Voting Begins April 3

Both the Democratic and Republican parties will have run-off elections on Tuesday, April 11.

Early voting for the runoff will take place April 3 through April 7 at the County Clerk's Office in the Colorado County Courthouse from 8 a.m. to 5 p.m. each day.

In Colorado County, there are two run-offs in the Democratic primary. There is one run-off election in the Republican primary.

In the Democratic primary, one run-off is for the nomination for U.S. Senate. The candidates are Barbara Ann Radnofsky and Gene Kelly.

There is also a Democratic runoff for lieutenant governor. The candidates are Maria Luisa Alvarado and Benjamin Z. Grant.

In the Republican primary, the run-off is for Court of Criminal Appeals Judge, Place 8, between Terry Keel and Charles Holcomb.

A light voter turnout is expected. Because of the anticipated light turnout, several polling places have been consolidated for voting on April 11.

Voters in Precincts 101 (Columbus- Glidden), 102 (Rock Island) and 103 (Garwood Nada) will vote at the Colorado County Services Facility at 305 Radio Lane in Columbus.

Voters in Precincts 201 (Weimar- Oakland) and 202 (Sheridan) will vote at Weimar City Hall.

Voters in Precincts 301 (Buescher- Shaw's Bend), 302 (Brushy and Freelsburg), 303 (Mentz), 304 (Bernardo), and 305 (Alleton-North Columbus) will vote at the County Agriculture Building at 316 Spring Street in Columbus.

Voters in Precincts 401 (Altair) and 402 (Eagle Lake) will vote at the Eagle Lake Community Center, 10 N. Walnut, in Eagle Lake.

and life purpose assessments and training. Computer Learning Center of 20 computers. The new 1,000 sq.ft. Art House offering a wide variety of arts and crafts training sessions and activities. And, a new Skills Program under development designed to teach youth 'hands on' practical skills that can be used for a lifetime.

Another board member stated that he felt 'the single most important thing accomplished thus far has been the level of trust and respect earned between the youth and adult volunteers. That trust is what gives us the ability to build something of lasting value'.

The directors of the program told us "we continue to have high expectations for each child and there has not been a single serious behavior problem between the children in the last 18 months. A remarkable 98% of the children never had to be sent home because of behavior problems. We continue to have a very low tolerance for poor behavior and expect a child's best behavior 100% of the time. Kids are growing up before our eyes and we see their hopes and their fears in very real terms. We also never lose sight of the fact that each child is on their own road of development."

**Cost Effectiveness:** The directors report that a significant number of children are being served at an extremely modest expense. The facility has no debt and no unpaid bills. Over 300 children can be served and immensely benefited for the rest of their lives on less money than it costs to incarcerate two kids. This is not to mention the far nobler goal of having vastly more productive, responsible, caring citizens in the community.'

**Scholastics:** The Program has over 20 computers with learning software and several adult volunteers able to assist children scholastically. Yet the need is extremely great. The directors report that there is a tremendous opportunity to assist the scholastic achievement of perhaps 20-40% of the elementary and junior high children in Eagle Lake but additional part time adult volunteers are always needed.

**Nondiscrimination:**

The program gladly accepts and serves all children, ages 9-17, re-

An Award of Financial Reporting Achievement has been awarded to the individual(s), department or agency designated by the government as primarily responsible for preparing the award-winning CAFR.

This has been presented to Raymie M. Kana, County Auditor.

The CAFR has been judged by an impartial panel to meet the high standards of the program including demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story and motivate potential users and user groups to read the CAFR.

The GFOA is a nonprofit professional association serving approximately 16,000 government finance professionals with offices in Chicago, Ill., and Washington, D.C.
