Jamison said he did not know how long the ceiling had been in place. The courthouse was built in 1891.

His secretary, Susan Rogers, said it was possible that the ceiling dated back to 1909; that was when a storm blew the clock tower off the building and it was replaced with a dome.

Jamison said he expected it to take several weeks to have repairs completed.

He also said he had no idea on the cost of the repairs, but said, the county was filing a claim with its insurance carrier.
