

Raiders To Battle For District Title Friday

Schulenburg beat Edna last week by a score of 21-14.

The Raiders have crept up the rankings to #4 in the state.

Rice has outscored district openents 140-27 in just three games while Schulenburg's margin is 94-48.

Rice has averaged over 100 yards more on offense than Schulenburg this year and leads the district with 441 yards per game.

Schulenburg does boast the toughest defense, only giving up 160 yards per contest.

Rice running back Ziggy Foster will look to top the 1,000 yard mark for the season, needing

only 48 more yards. He has found paydirt 11 times.

Quarterback Taylor Cook has already acheived that feat through the air with 1,123 yards on the season with 16 touchdown passes.

Foster and Cook are the district leaders in these categories.

Receiver Darkeith Pratt is the leading receiver with 368 yards and six touchdowns.

"Turnovers will be key, as is the case in all big games," said Dumont.
