Simply count the number of times the designated Christmas symbol appears in advertisements in the entire paper for the week, fill out the form and submit it by the deadline.

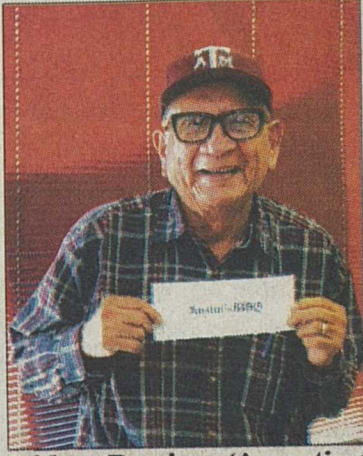
Deadline for this week's contest is 5 p.m. Monday, Dec. 18.
