ORDINANCE NO. 2007-03
 JUVENILE CURFEW

AN ORDINANCE MAKING IT UNLAWFUL FOR A MINOR, EXCEPT IN THE COURSE OF EMPLOYMENT, OR RETURNING FROM A SANCTIONED SCHOOL ACTIVITY, TO BE UPON THE STREETS OF EAGLE LAKE, TEXAS, BETWEEN THE HOURS OF 10:00 P.M. AND 5:30 A.M. THE NEXT MORNING; MAKING IT UNLAWFUL FOR ANY PARENT OR PERSON HAVING LAWFUL CUSTODY TO PERMIT A MINOR TO BE UPON THE STREETS WITHIN SUCH TIME LIMITS, UNLESS THERE IS A NECESSITY THEREFORE; PROVIDING THAT ANY VIOLATION OF THIS ORDINANCE SHALL BE A CLASS C MISDEMEANOR AND UPON CONVICTION SUCH VIOLATOR SHALL BE FINED A SUM NOT LESS THAN \$25 OR MORE THAN \$500; REPEALING CURFEW ORDINANCE 9507; PROVIDING FOR A SAVINGS CLAUSE; AND PROVIDING ITS EFFECTIVE DATE TO BE DATE OF PUBLICATION.

Bids must be received on or before March 22, 2007 at 10:00 o'clock a.m. and are irrevocable for 60 days from that time. Bids will be opened and read in the County Courtroom, Courthouse, Columbus, Texas at that time and date. Awarding of bids may be made on March 26, 2007.

Bidders for the road paving shall include in its bid proof of Workers' Compensation Insurance and General Liability Insurance Coverage in the amount of one million dollars (\$1,000,000). The successful Bidder for the road paving will be required to furnish a Performance Bond if the contract is in excess of \$100,000 and a Payment Bond if the contract is in excess of \$25,000.
