### Final Notice and Public Explanation of a Proposed Activity in the 100-Year Floodplain and Wetland

To: All interested Agencies, Groups and Individuals

This is to give notice that the City of Eagle Lake has conducted an evaluation as required by Executive Order 11988 and 11990 in accordance with HUD regulations at 24 CFR 55.20 to determine the potential affect that its activity in the floodplain and wetland will have on the human environment for Owner Occupied Program under HOME Contract #1000714. The proposed project(s) which is are located in City of Eagle Lake, Colorado County will be reconstructed or rehabilitated:

(1) 504 6th St , (2) 500 3rd St , Eagle Lake , TX

The City of Eagle Lake has reevaluated the alternatives to rebuilt in the floodplain and has determined that that the proposed housing reconstruction activities cannot be undertaken in any other location since relocation activities are not an option under the HOME Owner Occupied Program. There is no alternative other than not to perform reconstruction activities which would not serve the purpose of the HOME Program in providing safe, decent, and sanitary housing for low-income homeowners who currently reside in sub-standard housing and that it has no practicable alternative other than to demolish and reconstruct or do major rehabilitation to the unit(s). This activity will have no significant impact on the environment for the following reasons:

The proposed project site locations are already occupied by homes and therefore existing sub-standard homes will be replaced with standard dwellings.

Failure to provide reconstruction assistance would result in the continued unsafe and unhealthy living conditions for the nine households.

The new homes will be elevated above the base flood elevation, which will prevent flooding. Flood insurance will be provided for the homes.
