LEGAL NOTICE

Texas Rice Producers Board Biennial Board of Directors Election

Under the provisions of the Texas Commodity Referendum Law, Chapter 41, Texas Agricultural Code the 12-member Texas Rice Producers Board, 1806 Avenue D, Suite 106, Katy, TX 77493, is conducting a biennial board of directors election ending December 13, 2007, for four expiring terms. Any person living within the district boundaries who is engaged in the business of producing or causing to be produced, rice for commercial purposes, is eligible to vote, including owners of farms and their tenants and sharecroppers, if such person is subject to paying the assessment that is collected on a refund-only basis on the rice within the following districts:

DISTRICT 3 That area of Chambers County east of the Trinity River and South of US Highway I-10.

DISTRICT 4 (A) That area of Liberty and Chambers Counties west of the Trinity River, and(B) That area of Harris County north of Buffalo Bayou and east of US Highway 59.

DISTRICT 9 That area of Wharton County west of the Colorado River.

DISTRICT 10 (A) That area of Wharton County east of the Colorado River and north and west of US Highway 59 and (B) That area of Colorado County east of the Colorado River.

Any person qualifying to vote in the election may place his/her name in nomination for membership on the Texas Rice Producers Board. For a rice producer to be a candidate on the ballot, they must: (1) Reside in the district they wish to represent, (2) Draw a petition of 10 signatures of eligible rice producers from their district, and (3) Submit the petition to the Texas Rice Producers Board at the above mentioned address by November 9, 2007, which is more than 30 days prior to the election deadline. All eligible candidates will be placed on the ballot.

The election will be conducted by mail. The deadline for all ballots to be postmarked is midnight, December 13, 2007. Ballots must be mailed to the polling place at Texas Rice Producers Board, 1806 Avenue D, Suite 106, Katy, TX 77493. Any person qualified to vote who does not receive a ballot 15 days prior to the election may obtain one at the County Agricultural Extension Service offices.

PUBLIC NOTICE
