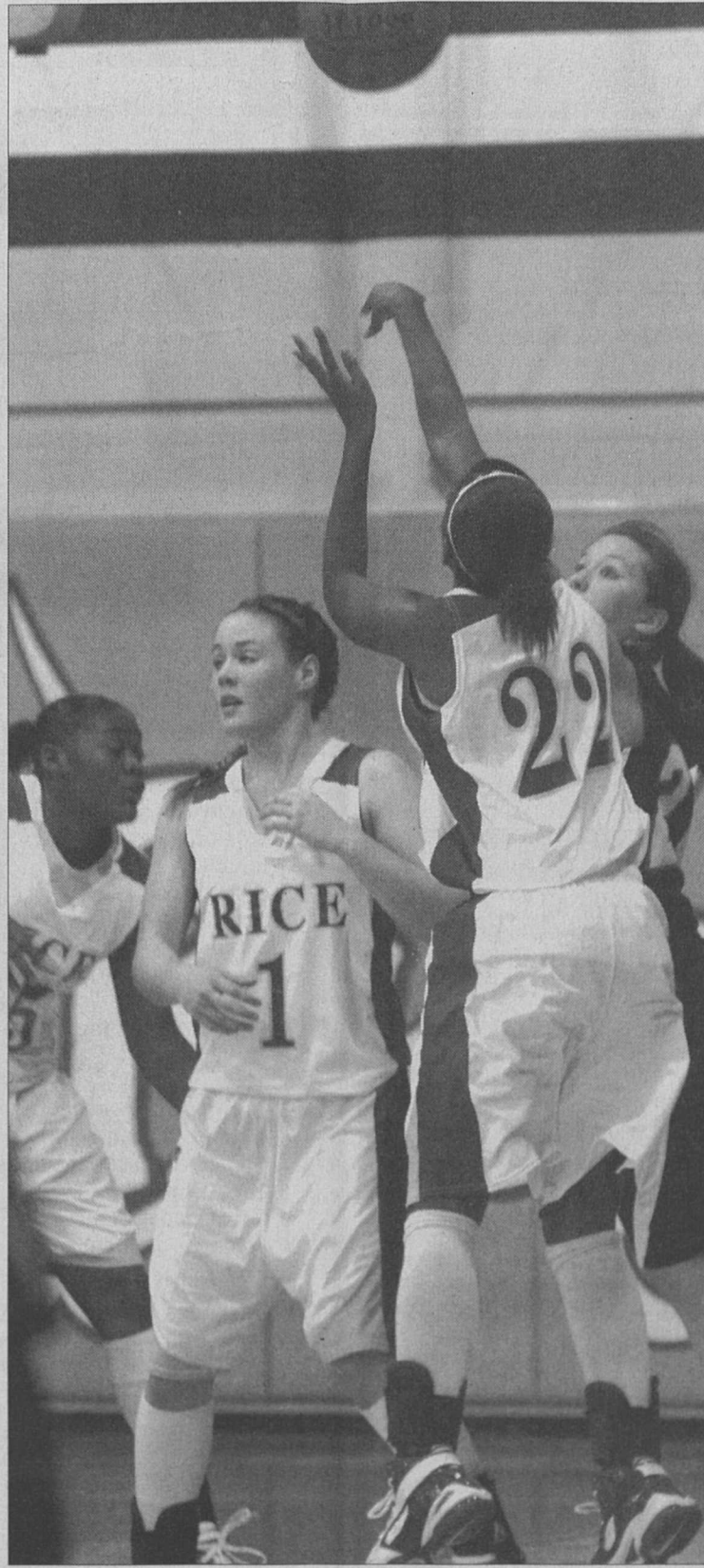

### COLORADO COUNTY COURTHOUSE REPORT

#### Three Civil Suits In District Court

Three civil suits were filed in the last week in Colorado County District Court.

On Nov. 30, Esther Bishop filed suit against Colorado Valley Transit District and James Mosley in a dispute arising from an accident on Dec. 2, 2005.

According to the suit, Bishop, who was in a wheelchair, was being prepared to be transported from a kidney center in Wharton back to her home in Weimar.

The suit claims that when Mosley attempted to take her out of the wheelchair he dropped her and she suffered a broken knee and ankle.

On Dec. 3, the contest of a will involving the estate of Lillie Belle Pophanken was transferred to district court from county court. The case involves a contest by Myrl Rau Youens, a sister of Pophanken, who died on Nov. 3, 2007.

On Dec. 4, Carey Stuart filed suit against Leigh John Bentley Jr., in a dispute over the quality of work performed by Bentley in removing a tree trunk, constructing a patio, and finishing a driveway for Stuart.

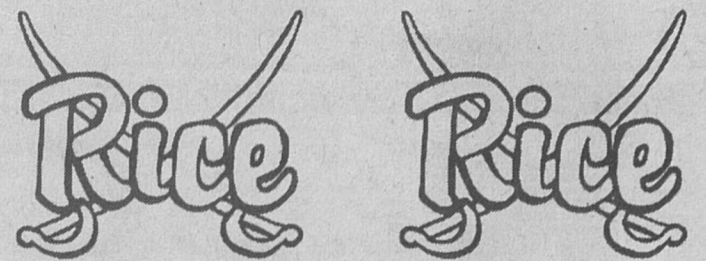
