AN ORDINANCE ESTABLISHING A TREE PRESERVATION ORDINANCE; PROVIDING FOR PUBLIC PURPOSE AND APPLICATION TO PUBLIC AND PRIVATE PROPERTY; SETTING FORTH UTILITY SERVICE PROVIDER RIGHTS AND RESPONSIBILITIES TO TRIM AND REMOVE TREES; SETTING FORTH THE CITY'S RIGHTS AND RESPONSIBILITIES TO TRIM AND REMOVE TREES; PROVIDING EXCEPTIONS; PROVIDING FOR ENFORCEMENT; PROVIDING FOR AN EFFECTIVE DATE; ESTABLISHING A PENALTY FOR VIOLATION, AND THE REPEAL OF TREE PRESERVATION ORDINANCE NO. 2002-15.

The City of Eagle Lake will receive bids for the 2007 TCDP Sanitary Sewer until 2:00 P.M. on Tuesday, March 18, 2008 at the City of Eagle Lake, 100 E. Main, Eagle Lake, Texas 77434-0038. The bids will be publicly opened and read aloud at the same date, time and place. Bids are invited for several items and quantities of work as follows:
1. Remove and dispose of existing 6-inch sanitary sewer line and furnish and install 6-inch ASTM D-3034 SDR 26 PVC gravity sanitary sewer line, 6-8' cut, with trace wire
2. Remove and dispose of existing 6-inch sanitary sewer line and furnish and install 6-inch ASTM D-3034 SDR 26 PVC gravity sanitary sewer line, 8-10' cut, with trace wire
3. Furnish and install asphalt pavement repair for sanitary sewer main lines and service lines
4. Furnish and install 4-inch Schedule 40 service line, all depths
