## NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION

NOTICE is hereby given that it is the intention of the City Council of the City of Eagle Lake, Texas (the "City") to issue interest-bearing Certificates of Obligation of the City to be designated and known as the "CITY OF EAGLE LAKE, TEXAS CERTIFICATES OF OBLIGATION, SERIES 2008" (the "Certificates") for the purpose of providing for the payment of contractual obligations to be incurred for the renovation of a water well, as well as payment of contractual obligations for professional services in connection with such project (including, but not limited to, financial advisory, legal, architectural, and engineering).
