NOTICE is hereby given that it is the intention of the City Council of the City of Eagle Lake, Texas (the "City") to issue interest-bearing Certificates of Obligation of the City to be designated and known as the "CITY OF EAGLE LAKE, TEXAS CERTIFICATES OF OBLIGATION, SERIES 2008" (the "Certificates") for the purpose of providing for the payment of contractual obligations to be incurred for the renovation of a water well, as well as payment of contractual obligations for professional services in connection with such project (including, but not limited to, financial advisory, legal, architectural, and engineering). The City Council tentatively proposes to authorize the issuance of the Certificates at its regular meeting place in the City Hall, Eagle Lake, Texas, at a Regular Meeting of the City Council to be commenced at 7:30 p.m., on the 13th day of May 2008, in an amount not to exceed \$300,000. The City Council presently proposes to provide for payment of the Certificates by the pledge of an annual ad valorem tax levied upon all taxable property within the City, within the limits prescribed by law, and by a limited pledge of \$1,000 of the revenues of the City's water and sewer system. The Certificates are to be issued, and this notice is given, pursuant to Section 271.041, et seq., Texas Local Government Code.
