NOTICE OF INTENTION TO ISSUE COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION

NOTICE IS HEREBY GIVEN that the Commissioners Court of Colorado County, Texas, will convene at 9:00 a.m. on the 9th day of June, 2008, at its regular meeting place thereof in the Colorado County Courthouse, 400 Spring Street, Columbus, Texas, and, during such meeting, the Commissioners Court will consider passage of orders and take such other actions as may be deemed necessary to authorize the issuance of the following: combination tax and revenue certificates of obligation in an aggregate principal amount not to exceed \$5,000,000 for the purpose of paying contractual obligations to be incurred for (1) the construction and improvement of the County Courthouse, (2) the construction and improvement of County roads, and (3) the payment of professional services and costs of issuance related thereto. The combination tax and revenue certificates of obligation will be payable from the levy of an annual ad valorem tax, within the limitations prescribed by law, upon all taxable property within the County, and a limited pledge (not to exceed \$1,000) of the revenue from the housing of prisoners in the county jail as authorized under Subchapter D of Chapter 361 of the Texas Local Government Code.

The combination tax and revenue certificates of obligation are to be issued, and this notice is given, under and pursuant to the provisions of the Certificate of Obligation Act of 1971, as amended, Local Government Code Section 271.041, et seq.
