

## Colorado County Courthouse Report

Eighteen individuals were sentenced in Colorado County Court on Wednesday, May 21. They included:

Pablo Avila, driving while intoxicated-2nd offense. Sentenced to two years probation, fined \$1,000, 10 days in jail, one year driver's license suspension and interlock device.

the county must seek competitive bids. Currently that level is \$25,000.

--Spending \$8,000 with the County Information Resources Agency to help fund development of standardized computer software for use by counties.

--A request by Peace Justice Frances Truchard for a second telephone line in his office. He said he had been personally paying for the second line himself.

--An application by Richard James Tucker for a limited land division of 19.285 acres of land in Precinct 3.

--Payment of \$500 to establish Web sites for the four peace justices in Colorado County. The sites would have forms that could be downloaded to pay fines or file civil cases.

"It's going to speed up a lot of things," Judge Billy Hefner said.
