bolted and ran through an unlocked door of the library and down the stairs.

"He's running," Hinze said someone called out.

The constable said he and a probation officer chased the man, who was wearing an orange t-shirt and blue jeans down the west stairs and through the first floor of the courthouse and out the east side of the building.

The said they lost sight of him as he went behind a building.

After a 30-minute search of the area, the unarmed escapee was taken into custody in an upstairs garage apartment on Front Street and Dewees, about three blocks from the courthouse.

He was arrested by DPS Troopers Patrick Mladenka and Josh West.

They said that residents in the neighborhood said they saw a man go in the direction of an unoccupied apartment.

After checking the apartment, they found the man. He offered no resistance.

The escapee was identified as Christopher Lee Hagan, 23, of Wharton.

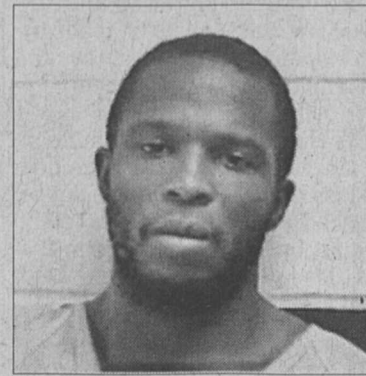

sexual assault of a child.

He was remanded to the custody of the Colorado County Sheriff by 25th Judicial District Judge Dwight Peschel, at which time he bolted from the courthouse.

Hagan now faces additional felony charges of escape and burglary.

## ATHLETIC MOUTHGUARDS

A mouthguard is a flexible appliance made from plastic that is worn in athletic and recreational activities to protect teeth from trauma. Anytime there is a strong chance for contact with other participants or hard surfaces, it is advisable to wear a mouthguard. Players who participate in basketball, softball, football, wrestling, soccer, lacrosse, rugby, in-line skating, martial arts, skateboards, and bicycling should wear mouthguards while competing.

A mouthguard can prevent serious injuries such as concussions, cerebral hemorrhages, incidents of unconsciousness, jaw fractures, and neck injuries by helping to avoid situations where the lower jaw gets jammed into the upper jaw. Mouthguards are effective in moving soft tissue in the oral cavity away from the teeth, preventing laceration and bruising of the lips and cheeks especially for those who wear orthodontic appliances.
